Management Discussion of Fund Performance

November 12, 2024

This Management Discussion of Fund Performance presents the portfolio management team's view on the significant factors and developments that have affected the ETF's performance and outlook in the six-month period ended September 30, 2024 (the "period"). If the ETF was established during the period, "period" represents the period since inception.

In this report, "Mackenzie" and "the Manager" refer to Mackenzie Financial Corporation, the manager of the ETF. In addition, net asset value ("NAV") refers to the value of the ETF as calculated for subscription and redemption purposes, on which the discussion of ETF performance is based.

Results of Operations

Investment Performance

During the period, the ETF returned 4.5% (after deducting fees and expenses). This compares with the ICE BofA Global Broad Market (Hedged) Index return of 3.9%. All index returns are calculated on a total return basis in Canadian dollar terms. Investors cannot invest in an index without incurring fees, expenses and commissions, which are not reflected in the index returns.

In response to cooling inflation and weaker labour markets, the U.S. Federal Reserve, the European Central Bank and the Bank of England lowered interest rates during the period. The U.S. Federal Reserve reduced its federal funds rate by 50 basis points to a target range of 4.75%–5.00%. Global bond yields declined in anticipation of lower central bank rates. Meanwhile, the Bank of Japan raised its policy rate to 0.25% from zero, while indicating that it will consider additional increases depending on economic and inflation data.

The ETF outperformed the index, with security selection in corporate bonds, particularly in the infrastructure sector, contributing to performance. A longer duration (higher sensitivity to interest rates) in foreign government bonds also contributed to performance as interest rates fell.

Conversely, underweight exposure to corporate bonds in the securitization sector detracted from performance, as did the ETF's currency management.

Over the period, the ETF's exposure to foreign government bonds increased in response to the portfolio management team's evolving view of the sustainable debt mix. Exposure to corporate bonds decreased, based on the team's assessment of valuations and opportunities, and as a result of market movements.

Environmental, Social and Governance ("ESG") Impact

Over the period, the portfolio management team rebalanced the ETF to enable a more diverse mix of labelled sustainable debt than in the past. The proportion of ESG-labelled debt decreased to 68% from 79% of the ETF's fixed income investments. Green bonds decreased to 35% from 49%, sustainable bonds increased to 20.5% from 18%, sustainability-linked bonds decreased to 7.5% from 8%, and social bonds increased to 5% from 2%. Transition bonds, which fund a company's transition toward reduced environmental impact or lower carbon emissions, stayed at 0%. The remaining 32% of the ETF's fixed income investments had issuers the team considers to be ESG leaders relative to their peers.

Net Assets

The ETF's net assets increased by 3.6% during the period to \$194.0 million. This change was composed primarily of \$8.7 million in net income (including any interest and/or dividend income) from investment performance, after deducting fees and expenses, and a decrease of \$2.0 million due to net unitholder activity (including sales, redemptions and cash distributions).

Recent Developments

The portfolio management team believes that the U.S. Federal Reserve's federal funds rate cut in the period aligned with market expectations and demonstrated the central bank's willingness to make significant moves in its policy stance when necessary. Because the team expects accommodative monetary policy to continue in response to declining economic indicators, the team favours having duration exposure (sensitivity to changes in interest rates) in North America.

The team believes that if the U.S. economy avoids a recession through a "soft landing," high-yield assets will be attractive. The team continues to prefer higher-quality high-yield exposure and expects that credit selection will be key to investment success. These criteria are part of the ESG investment strategy.

The following changes to the Mackenzie Funds' Independent Review Committee occurred:

- effective September 13, 2023, Saijal Patel was appointed;
- effective March 5, 2024, Atul Tiwari resigned; and
- effective April 30, 2024, the terms for Robert Hines and George Hucal expired, and Rebecca Cowdery was appointed.

Related Party Transactions

Management Fees

The annualized management expense ratio ("MER") for the ETF during the period ended September 30, 2024, was similar to the MER for the year ended March 31, 2024. Total expenses paid vary from period to period mainly as a result of changes in average assets in the ETF. The MERs are presented in the *Financial Highlights* section of this report. The ETF paid management fees to the Manager at the annual rate of 0.50%.

The management fee for the ETF is calculated and accrued daily as a percentage of its NAV. The ETF's management fees were used by the Manager to pay for the costs of managing the investment portfolio of the ETF, including providing investment analysis and recommendations, making investment decisions, making brokerage arrangements for the purchase and sale of the investment portfolio and providing other services, and to pay for all costs and expenses (other than certain specified fund costs as more fully described in the Prospectus) required to operate the ETF.

Other Related Party Transactions

Investment funds managed by Mackenzie and its affiliates may invest in the ETF in accordance with the investment objectives of those funds. At September 30, 2024, funds managed by Mackenzie owned 49.8% of the ETF's NAV, and funds managed by I.G. Investment Management, Ltd. owned 43.9% of the ETF's NAV. All related party transactions are based on the current market price. As a result of these investments, the ETF may be subject to large transaction risk as discussed in the Prospectus. Mackenzie manages this risk to reduce the possibility of any adverse effects on the ETF or on its investors, through such processes as settling transactions in kind, charging creation and/or redemption fees for transactions settling in cash, and establishing appropriate order cut-off times for transactions.

The ETF did not rely on an approval, positive recommendation or standing instruction from the Mackenzie Funds' Independent Review Committee with respect to any related party transactions in the period.


Past Performance

The Manager may reimburse the ETF for certain brokerage commissions and other transaction costs (including those payable to the custodian or its agents). The Manager may make these reimbursements at its discretion and stop these reimbursements at any time without notice.
- (4) The ETF's portfolio turnover rate indicates how actively the ETF's portfolio advisor manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the ETF buying and selling all of the securities in its portfolio once in the course of the period. The higher the ETF's portfolio turnover rate in a period, the greater the trading costs payable by the ETF in the period, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of the ETF. The portfolio turnover rate is not provided when the ETF is less than one year old.
